		<p>LA reported that the committee group for the Ickford Pavilion has now been formed and a meeting will be held tomorrow. LA also reported that she has spoken to the Village Hall committee and explained to them that Children's Parties held at the Pavilion will only be allowed a maximum of 15 guests as the village hall will be better suited for anything larger.</p> <p>LA suggested that any monies left over at end of year when all costs have been taken off could be passed to the Village hall. No agreement was made on this issue.</p> <p>LA also asked the Parish Council if the January 2019 date for the Pavilion Committee to take over all running costs of the Pavilion could be moved forward by a couple of months, as the actual date the Pavilion opened was later than expected because the building works were held up. Parish Council agreed to this.</p> <p><b>Internet for Pavilion</b></p> <p>LA also reported that she has been looking further into the possibility for internet in the Pavilion, she has been in Touch with EE who seem to have the best option for installing a 4G Router. She is going to fill in the application for LAF funding for the 18-month contract EE offer. Parish Councillors all agreed to 18month contract.</p>	LA
